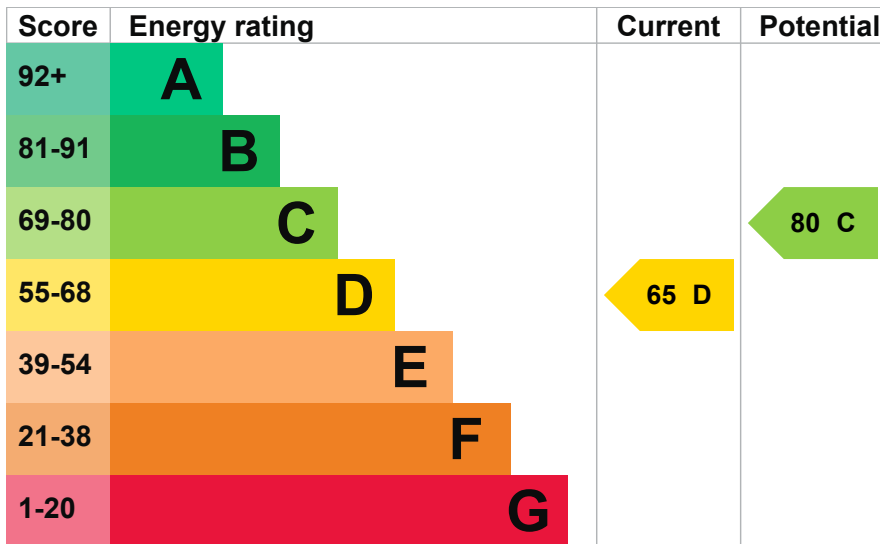

## How this affects your energy bills

An average household would need to spend **£775 per year on heating, hot water and lighting** in this property. These costs usually make up the majority of your energy bills.

Typical installation cost	£3,300 - £6,500
