



## How this affects your energy bills

### **Step 1: Floor insulation (solid floor)**

Typical installation cost	£4,000 - £6,000
Typical yearly saving	£22
Potential rating after completing step 1	71 C

#### Step 2: Heating controls (room thermostat and TRVs)

Typical installation cost	£350 - £450
Typical yearly saving	£57
Potential rating after completing steps 1 and 2	74 C

### Step 3: Solar water heating

Typical installation cost	£4,000 - £6,000
Typical yearly saving	£25
Potential rating after completing steps 1 to 3	75 C

### Step 4: Solar photovoltaic panels, 2.5 kWp

Typical installation cost	£3,500 - £5,500
Typical yearly saving	£347
Potential rating after completing steps 1 to 4	88 B
