



How this affects your energy bills

An average household would need to spend £1,532 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy hills

You could save £838 per year if you complete the suggested steps for improving this property's energy rating.

Estimated energy needed in this property is:

- 11,885 kWh per year for heating
- 3,248 kWh per year for hot water

Impact on the environment

Step 6: Double glazed windows

Replace single glazed windows with low-E double glazed windows

Typical installation cost	£3,300 - £6,500
Typical yearly saving	£44
Potential rating after completing steps 1 to 6	67 D
