



## How this affects your energy bills

An average household would need to spend £586 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy bills.

### Step 2: High heat retention storage heaters

Typical installation cost	£400 - £600
Typical yearly saving	£131
Potential rating after completing steps 1 and 2	77 C

#### Step 3: Double glazed windows

Replace single glazed windows with low-E double glazed windows

Typical installation cost	£3,300 - £6,500
Typical yearly saving	£55
Potential rating after completing steps 1 to 3	80 C
