

# Rules on letting this property


Properties can be let if they have an energy rating from A to E.

## How this affects your energy bills

Potential rating after completing steps 1 to 3	67 D

### Step 4: Solar photovoltaic panels, 2.5 kWp

Typical installation cost	£5,000 - £8,000
Typical yearly saving	£279
Potential rating after completing steps 1 to 4	78 C
