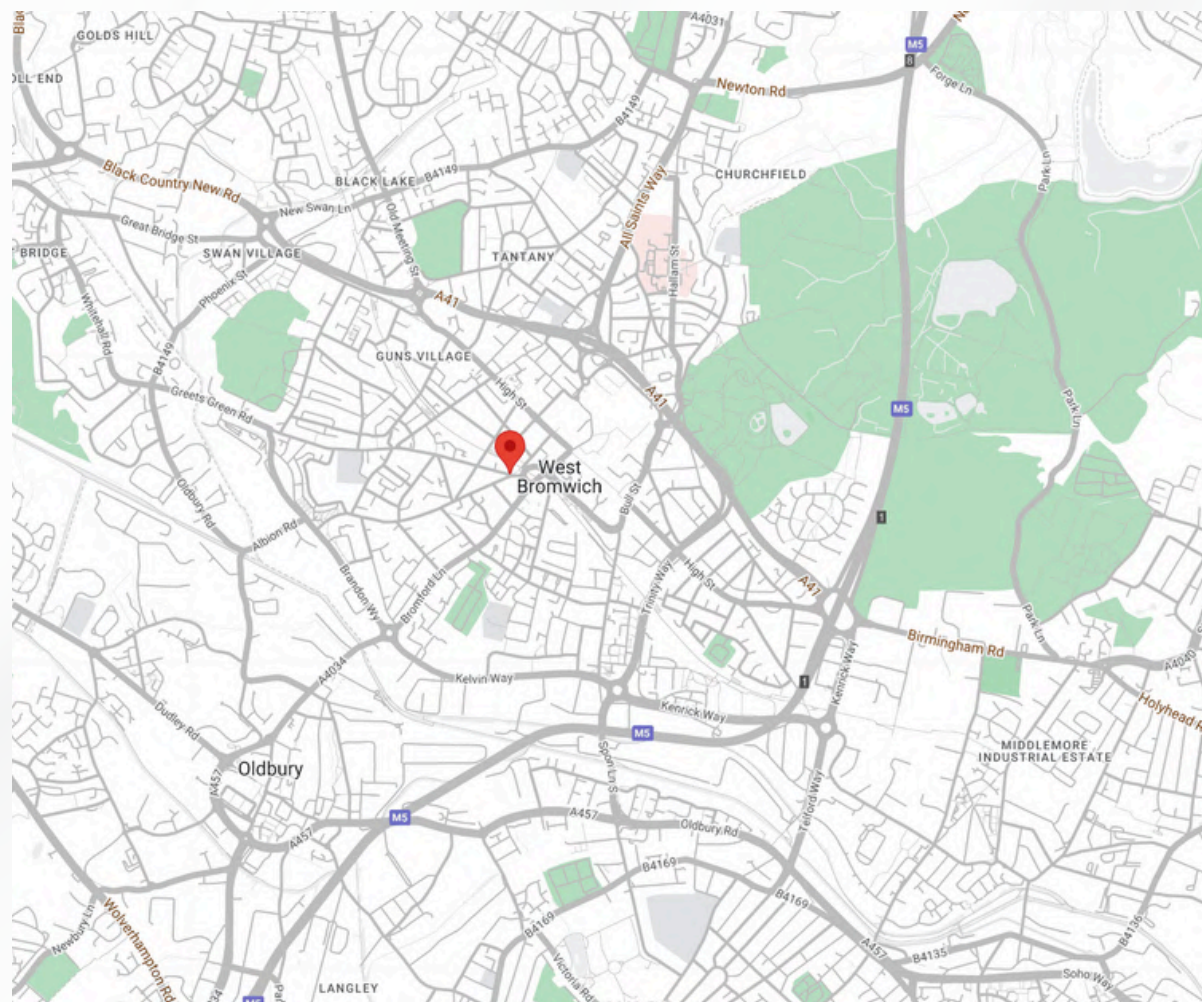
Landchard House benefits from being within easy walking distance of all local amenities and the nearby Tram line and bus station.
