## Location

The property is situated in Gillity Shopping Village, a community shopping centre approximately 3 miles to the southeast of Walsall town centre. The property comprises a ground floor mid parade retail property extending to 1,034 sq. ft. (96.1 sq m) and formerly traded as a gymnasium. There is an open plan retail area, with storage, and kitchen beyond.
