


Properties can be let if they have an energy rating from A to E.

# **Energy rating and score**

# Breakdown of property's energy performance

#### Features in this property

# How this affects your energy bills

An average household would need to spend £1,262 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy bills.
